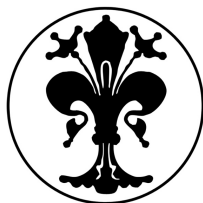

The instrument belongs to Liuteria Toscana, and it is in the following conditions: [NEW] \_\_\_\_\_

The renter is responsible for the instrument and all the material given with the instrument for all the period of rent from the moment in which the rent starts till the moment the instrument is given back to Liuteria Toscana.

2) At the end of the contract that has the duration of 6 months starting from the date \_\_\_\_\_, the renter agrees to return the instrument at the date of expiration of the contract in perfect conditions.

Except in the case of communication between the Renter and Locator, to be given before the expiration date of the contract, the contract is automatically renewed for other 6 months upon anticipated payment of other 6 months fee.

The Renter is responsible for the instrument and all accessories part of the contract and will refund the total value in case of lost, theft or damage.

String change or other work due to normal use must be paid by the renter.

For any work necessary to be done on the instrument they must be done exclusively in the laboratory of Liuteria Toscana, otherwise the contract will be considered closed.

3) The instrument rented is property of Liuteria Toscana and the renter cannot sell or rent it unless there is a written authorisation from Liuteria Toscana.

4) For the instrument rented the renter must pay to Liuteria Toscana a monthly fee of € \_\_\_\_\_ (Tax included). The payment must be done at the beginning of the semester. In case the renter gives back the instrument before the end of the contract no refund will be done of the months payed.

In case the Renter does not pay Liuteria Toscana has the right to consider finished the contract and to require the instrument back.

In any moment of the rent the Renter can decide to buy the instrument having the right to deduce from the total price the 70% of what he has payed till that moment for rent.

The instrument is given in perfect condition and in the same condition it must be given back at the end of the contract.

5) For any legal controversy relative at the interpretation and application of this contract both the Renter and the Locator agree for the jurisdiction of the Florence (Italy) tribunal with declared and definitive surrender to use any other tribunal.

The Locator commits to use personal data included in this contract only for the use of the contract and not to spread them in any way.
